TUITION POLICY

MACC considers student enrollment to be a commitment to the entire school year and bases its fiscal decisions on this assumption. We rely on parents meeting their financial responsibilities promptly in order to maintain teacher salaries and school expenses. **It is each parent's responsibility to read and comply with the policy stated below and in the Admission Agreement.**

1. The **application fee** is due at the time of application. The application fee is non-refundable.
2. To accept your child's class placement and secure his/her place for the school year, you must submit the **first tuition installment** with any necessary enrollment forms.
3. **Tuition** is an annual amount.
4. MACC extends a 10% discount for a second and/or third child in a single family when concurrently enrolled. The discount applies to the lesser tuition rate(s).
5. You may pay tuition in ten equal installments. The installments are due on the first of each month, August through May. Any tuition payment submitted after the 7th of the month is late and incurs a \$35 late fee. If a parent contacts the Director before the 7th of the month, the Director may waive the late fee at his/her discretion. If the 7th falls on a weekend or on a day school is closed, the next school day is considered to be the 7th.
6. Tuition installments are non-refundable.
7. Illnesses and vacations are not deductible from tuition.
8. When a student is voluntarily withdrawn for any reason, tuition must be paid in full for each calendar month that the student was in attendance on the basis of 1/10th of the annual tuition. A **written notice must** be given to the Director 30-days in advance of withdrawal. If a parent withdraws the student in the middle of a month, the installment for that month will not be prorated.
9. MACC assesses a fee for any returned check equal to the fee charged by our bank PLUS \$10.00. If tuition is in arrears by more than one installment, the student will be dismissed.
